RELEASE FORM

1. While reasonable care is taken to prevent accidents, injuries, sickness, escape, fire, etc., animals are placed at the Valley View Kennels at the risk of the owner. In no case shall Valley View Kennels be in any way liable or responsible. The responsibility and/or liability of Valley View Kennels, in no event shall exceed the sum of Two Hundred Dollars (\$200.00) and the undersigned agrees to limit the responsibility of Two Hundred Dollars (\$200.00) and no more, and agrees not to claim any damages against Valley View Kennels of any nature whatsoever either by way of contract, equity, negligence or otherwise, in excess of said sum.

2. In the event of illness or injury, Valley View Kennels will contact your veterinarian. If he or she is not available, Valley View Kennels will use a qualified veterinarian known to the kennel. The cost of medication and treatment will be at the owner's expense. In the event of medical emergency the owner has authorized Valley View Kennels to spend up to \$_____ on the pet's behalf. If in the event of an emergency that is required more than the amount of money stated above the owner wants Valley View Kennels to

3. Unacceptable behavior by pets, resulting in facility damage, injuries to an employee, injuries to another pet, or to itself will be estimated and charged to the owner of pet at time of pickup. Payment of this charge is due before pet will be released to the owner.

4. The State of New Jersey requires all dogs and cats be vaccinated against rabies. Valley View Kennels requires proof of vaccination for all family pets. The owner is responsible for regular veterinarian checkups and for keeping his or her pet updated on inoculations and healthy. All inoculations must be given ten days prior to boarding at Valley View Kennels.

5. Valley View Kennels takes precautions against disease transmissions by disinfections and for parasite infestation through spray control. However, Valley View Kennels can not guarantee against illness or parasites. We do, however, require flea and tick treatment protection for your family pet.

6. Payment for services is due upon pickup of pet. (If the family pet is staying ten (10) days or more, a 50% deposit must be paid during drop off of the pet). Cash or check only. A drivers license is required for all checks. Valley View Kennels does not accept credit cards at this time.

7. Valley View Kennels will only release the pet to the owner. If the owner would like someone else to pick up the pet, prior notifications must be made with the Valley View Kennel. For the protection of owner's pet, Valley View Kennels reserves the right to check IDs prior to the pet's release. Check-out time is 11:00 a.m. (noon). If the owner can not pick up his or her pet by that time, the owner will be charged an extra day. In the event the owner does not retrieve their pet by the agreed upon date, the rate shall be doubled, on a per day basis, for each extra day the dog is boarded. If there is no available space for your pet, if it over stays, the pet may be moved to a crate and will be walked twice a day.

8. All services rendered must be paid at time of pick-up. Valley View Kennels shall have, and hereby granted, a lien on the animal for any and all unpaid charges resulting from your staying at the kennel. This lien includes but not limited to reimbursements for veterinarian care, damages to property, grooming, and all extra services.

9. The owner is responsible for giving Valley View Kennels all information pertaining to his or her family pet. Since lack of information may result in sickness or injury, please be as thorough as possible when giving pet information. The owner also verifies all information given to Valley View Kennel is truthful and complete, by signing below.

10. It is understood by Valley View Kennels and owner that all provisions on this contract shall be binding by both parties, their heirs, administrators, and assigns of the owner of the within named animal. By signing below, the owner understands all of the above and agrees to follow all of Valley View Kennel's policies and procedures.

11. The owner understands that Valley View Kennel is designed to board family pets only. Valley View Kennel is not responsible for any harm if the owner chooses to board a working pet, show pet, etc. Valley
